Thanks to our generous donors the SIOR Foundation was able to grant a record-breaking total of \$178,797 during our Fiscal Year Sept. 1, 2008 – Aug. 31, 2009 (15% more than 2007-08). We hope you will help us continue to fund these important initiatives, which include:
